- Hand assembly of small parts into Product Circuit Boards. Parts range in size from #4 screws to several inches. Parts range from small subassemblies to transformers that weigh up to 20 pounds.
- Using hand tools such as pliers and screwdrivers.
- Using soldering irons and electric tools for installing screws and nuts and several other components.
- Performing visual inspection of all parts that pass through the workstation
